## a) Scholarship Committee – Keith Head

Following the 2019 AGM the scholarship Terms of Reference were finalized and signed. The scholarships are open to continuing degree and diploma students in the College of Agriculture and Bioresources. Scholastic standing, involvement within their local community, the college and university, and the wider agricultural industry will be important selection criteria.

The Award will be funded completely by ongoing annual donations from Ag grads and other supportive individuals.

In April the SAGA Undergraduate Award was announced to the students and 25 eligible applications were received.

Two \$3000 scholarships were awarded at the ASA Bean Feed. The recipients are Amanda Loeffen and Brooklyn Bourgeois, both 4<sup>th</sup> year Animal BioScience majors.

The response to the Award has been quite positive. Contributions in 2019 totaled \$10,070. The committee would like to thank SAGA members for their generous support.

## c) Membership/Website – Vern Racz, Keith Head, Dennis Ewanus

#### Membership

Membership as of Oct 31, 2019 was 1811. There were 85 Annual Members, 50 Honorary Life Members, and 1676 Life Members.

In 2019 there were 78 Annual and 45 Life memberships issued. Two Life Members became Honorary Life Members.

There were 42 Annual memberships that were not renewed in 2019, 2 deceased Honorary Life Members, and 14 deceased Life Members.

There was a net increase of 65 members in 2019.

Annual members tend to renew their memberships every ten years, ie when their reunion years roll around. Vern addressed this last year by contacting all the Annual members in January offering them a chance to roll their annual memberships into Life Memberships. There were no takers.

He was also considering sending out renewal notices to Annual members as a way of keeping them current.

#### Website

During 2019 website underwent some upgrades to the software, security, and automation at a cost of \$1484. Website maintenance and domain costs were \$1957.99. Steve Dawe at the Webstation continues doing our website maintenance. Steve also sends out the e-mail versions of the Newsletter.

The Reunion Registration system works very well and is an efficient means of managing the funds, the registrants, and membership updates. There are the usual glitches but Dennis keeps the system running smoothly.

Information is being archived on the site. SAGA Newsletters back to 1975 are now available on the site. Minutes of the Executive meetings and Annual Meetings are also being added to the site.

#### d) Newsletter - Ewald Lammerding

The year has been eventful. Welcome to John Hauer, '84 C, who has came aboard to lend a hand.

Three advertisers, Municipal Hail, FCC and BrettYoung Seeds, who had been with us for 2018-19, reupped for 2019-20. The fees for this advertising significantly reduces our publishing costs.

This fall, two things occurred that had us back on our heels; the unexpected passing of Vern Racz, and a pile of returned Newsletters of the last three issues.

With the returns we discovered we had been mailing to 40 some addresses of either deceased grads [that we had no knowledge of], or many that were no longer viable. The stash had been piling up somewhere at the main Post Office or some corner of the Dean's office, either way we had been mailing to non-existent entities without knowing, a cost we could have done without. There were a few nasty comments on some to stop pestering them, but of course we didn't know that till now.

Vern was our Membership Chair, and because Tanya Napper had moved on, the mailing lists had become Vern's job. He was in the process of paring what he could, but had not had time to complete the task, nor have any knowledge of the returnees.

Charlene graciously allowed Keith Head access to Vern's files, and together with Dennis Ewanus' computer savvy, and lots of tracking and phone calls, we were able to finish what Vern had begun. We to be as ruthless as possible for the cause of reducing costs; the end result, we cut the hardcopy mailing list by almost 80, down to 675 addresses.

Unfortunately, this put us considerably behind schedule, and in a cascading manner of problems, we were two weeks late in getting the December issue of *The SAGA* out to our members. But, no one yelled at us, and we hope everyone received their mailed copy. Alas, with the thorough cleaning of both versions we find that instead of 2200 members, we are actually around 1850.

For emailing, we changed things somewhat. Instead of the College (and Tanya) doing all of it for us, we now ask Hamish and the Development Office to send only to students and faculty. We switched to our Website Manager to handle emailing to Ag Grads, where we can control any problems, right-off having about 30 bouncebacks. But fixing them means finding the correct email address, so much detective work needs to be done in that area.

We also wrote a piece in the Newsletter explaining the costs and our wish to reduce them, and asking any grads that could, to switch to email. Of course many cannot for various reasons, but we have received 15 requests so far asking that we do so. So now the mailing list is down to 660.

And our usual complaint; not near enough input from our fellow grads. It used to be common, but for whatever reason it no longer happens. Thank you, once more, to Irene Ahner for a fun Prairie Chicken.

But we received many comments about the wide open layout, with easy access to everywhere.

This year we enjoyed the company of what we think were our first double centenarian guests. Thomas Drever, a 1939 College grad, and Harold Chapman from the 1943 College. ## h) Crop Production Week – Jo-Anne Relf-Eckstein

The Crop Production Week Saskatchewan Inc. is a non-profit organization formed in 2005. The corporation is a membership corporation, with three classes of membership: Regular, Associate, and Advisory.

The 2019 Crop Week was held from January 14 to 18, 2019. The organizations held their AGMs and information meetings at various locations in Saskatoon, including the Prairieland Park, TCU Place, Radisson Hotel, and the Saskatoon Inn. Saskatchewan Soil Conservation Association held its convention at the Turvey Centre in Regina on February 5, 2019.

The Western Canada Crop Production Show, held at Prairieland Park, had an attendance of 19,953 in 2019.

A significant organization structure change occurred in April 2019 when five individual CPW members formed a separate organization. Sask Barley, Sask Canola, Sask Flax, Sask Oats, Sask Pulse, and Sask Wheat, incorporated as CropSphere. The remaining Crop Week groups voted to continue operating as a volunteer-run organization. Directors are identified in the Appendix. Membership includes:

- SAGA, Agri-ARM Applied Research Management, Canaryseed Development Commission of Saskatchewan, Saskatchewan Alfalfa Seed Producers Development Commission, Saskatchewan Forage Seed Development Commission, Saskatchewan Mustard Development Commission, Saskatchewan Seed Growers Association, Saskatchewan Soil Conservation Association, Saskatchewan Winter Cereals Development Commission (Regular)
- CropSphere (Regular)

- College of Agriculture and Bioresources (Associate Member), Saskatoon Prairieland Park Corporation (Advisory Member)
  - CPW continues to operate according to the Articles of Incorporation and Bylaws.
- The primary source of revenue is membership fees. Each Regular Membership group contributes a \$250 membership fee. Additional financial support provided by the Ministry of Agriculture for advertising and promotion of meetings of the CPW members.
- The 2019-2020 Board of CPW directors elected at the AGM April 10, 2019 include: Darren Yungman (Chairman) and Danny Petty (Secretary/Treasurer), both elected by acclamation. Mike Shewchuk, Darren Yungman, and Danny Petty were appointed as signing officers.
- Mooseworld will continue to maintain the CPW website.

The Financial Position of CPW as of October 28, 2019:

- Chequing account balance of \$18,038.52 GIC Renewal 1 year non-redeemable rate is 1.969% (\$30,000)
- Total Liabilities and Equity \$48,038.52 (October 28, 2019)
- \$4,500 was paid to Prairieland for including CPW agendas in the CPS Show Guide.
- PROJECTED INCOME: Membership invoices for 11 members @ \$250, total budgeted 2019/20 \$2,750;
   Sponsor Income \$5,000; Interest Income \$590.00, for TOTAL PROJECTED INCOME \$8,340.00
- PROJECTED EXENDITURES: Administration \$682.50 9 includes one month payment to administrator for transition to volunteer Treasurer); Promotion/Advertising \$4,5000; Website \$1,300, Administration expenses \$400.00; Incorporation Fee \$45.00 TOTAL PROJECTED EXPENDITURES \$6,927.50, CropSphere Group covered the cost of reception January 13<sup>th</sup>, 2020.
- PROJECTED SURPLUS \$1,412.50

Despite the separation into two corporate entities, the close relationship with CPW and these groups continues. The CropSphere group is one member of the CPW Board, and co-committee members participate in the CPW meetings.

- Directors and staff of the CPW member organizations are invited to attend the CropSphere 2020 Reception, Monday, January 13<sup>th</sup>, from 6:00 PM to 9:00 PM, TCU Place. The CropSphere group will cover the expense of this event, whereas, in the past, CPW was a co-sponsor.
- Financially, the CropSphere group will pursue their sponsorship from the Ministry of Agriculture. CPW
  will apply separately to the Minister of Agriculture, explaining the separation of CPW groups with
  CropSphere groups.

Keith served as Crop Production Week Chair since 2011 and Dennis served as Treasurer since 2011 as well as being an Assistant Registrar in 2010. Also, as indicated in his Lifetime Membership Award, Vern Racz served as Membership / Website chair from 2008 to 2019.
