Membership – Henry de Goojier

The current Covid pandemic continues to have a negative effect on the membership of the association. As of October 31, 2021 SAGA membership has decreased to 1757 ag grads. There are 53 Annual Members, 45 Honorary Life Members, 3 free memberships and 1656 Life members. This is a reduction of approximately 90 members from the previous year. While many of these were expiring annual memberships, the cancellation of the 2021 Ag Grad reunion banquet, traditionally a time where a number of life and annual memberships are purchased, has significant reduced the issuance of new memberships. The restrictions around public gatherings and the University of Saskatchewan conducting on-line versus in-person classes for the 20-21 academic year has also limited the outreach to new graduates from the college. In 2021 there were 14 new memberships issued.

Maintaining current contact information for the membership continues to be a priority. The primary and increasing method of contact with SAGA members is through email versus Canada Post. We currently have email addresses for approximately 60% of SAGA members. However, email addresses tend to change a bit more often than mailing or street addresses, so every mailing of the SAGA newsletter does bring in a list of members for which we no longer have a valid address. Currently we don't have current contact information for approximately 2% of our members. Thank you to the SAGA members who do send their new contact information to us and thanks to the efforts of Ewald, Hamish and the rest of the executive, we are able to track down new information for many and re-establish contact with them.

g) Crop Production Week - Jo-Anne Relf-Eckstein

The Crop Production Week (CPW) Saskatchewan Inc. is a non-profit organization formed in 2005. The corporation is a membership-based corporation, with three classes of membership: Regular, Associate, and Advisory. SAGA holds a Regular Membership.

The CPW Saskatchewan Inc.'s main function is to support the organization of member events that coincide with the Crop Production Week. Most members hold their AGMs or update meetings in Saskatoon in early January, a time coinciding with the combined Western Canadian Crop Production Show and CropSphere Conference and the SAGA Reunion.

The 2021 Western Canada Crop Production Show and CropSphere were canceled due to the pandemic. The CPW Saskatchewan Inc. organizations held their AGMs during the traditional week, but instead of face-to-face meetings, the AGMS were virtual and delivered using a cloud-based video conferencing service. For several organizations, mainly the crop-based organization, the delivery of the meetings using Zoom webinar and voting systems was coordinated by the AV Technical staff Prairieland Park. The staff patiently worked with the different organizations, scheduling dry runs for directors located in rural locations in order to test their internet connections and become comfortable with the remote meeting style. Overall, AGM attendance was up for most groups with increased participation by non-voting members.

Throughout the 2021-2022 year, the COVID-19 pandemic persisted and continued to impact how meetings were conducted. The CPW Saskatchewan virtual AGM was held on April 08, 2021. Here are the highlights of the meeting:

- The 2021-2022 Board of CPW Saskatchewan directors agreed to remain in their current positions: Darren Yungman, Chairman, and Danny Petty, Secretary/Treasurer, both elected by acclamation.
- Membership fees stayed the same, \$250 for each member group including Saskatchewan Ag Grads
 Association, Canaryseed Development Commission, Saskatchewan Seed Growers Association, Sask
 Winter Cereals (Winter Cereals Canada), Sask Alfalfa Seed Producers Development Commission,
 CropSphere (c/o Sask Wheat Development Commission), AgriARM (c/o IHARF), Saskatchewan
 Forage Seed Development Commission and Saskatchewan Mustard Development Commission. The
 College of Agriculture & Bioresources is an Advisory member (no membership fees).

- The Financial Position, on an accrual basis as of March 31, 2021, is reported as follows:
 - TOTAL ASSETS \$50,961. Chequing Account balance of \$19,292. GIC Renewal a one-year non-redeemable Term Deposit (\$30,000 at 1.000 %), Accounts Receivable \$1,668.
 - TOTAL LIABILITIES AND EQUITY \$50,961. Opening Balance Equity \$59,961, Unrestricted Net Assets -\$11,759, Net Income \$2,758.

TOTAL INCOME \$7,842 derived from Sponsorship (\$5,000) provided by the Ministry of Agriculture for advertising and promotion of meetings of the CPW Board members, Membership Fees (\$2,250 – 9 Regular membership fees @\$250), and Interest (\$592).

TOTAL EXPENSES \$5,083. The main expense is advertising the AGMs. Other expenses include Website Maintenance by Mooseworld (\$532) and Banking Fees (\$51).

NET INCOME \$2,758 reflects a change from \$1,684 in the previous year due to reduced administrative costs. Contracted Services shifted to volunteer commitments such as meeting scheduling, recording, and financial accounting by Danny Petty.

TOTAL PROJECTED INCOME 2021/22 is \$7,750 sourced from Membership Fee for 9 members @\$250, Sponsor Income \$5,000, and Interest Income \$500.

TOTAL PROJECTED EXPENDITURES 2021/22 \$7,505. Promotion/Advertising (\$4,5000); Website (\$1,000), Administration expenses (\$400) for postage, meeting charges), Bank service charges (\$60), Incorporation Fee (\$45).

PROJECTED SURPLUS 2020/21 Budget \$245.

The AGMs for the 2022 CPW Saskatchewan Inc and Crop Sphere organizations are scheduled for four days, January 10-13th. Prairieland Park will provide the AV support for several of the organizations as they chose either a virtual-only AGM as in January 2021 or a hybrid format, a combination of an in-person meeting at Prairieland Park with remote access available through the Zoom teleconferencing system. Following the same process as the previous year, a common registration system, saskcrops.com, and advertising for the AGMs were prepared. All groups were provided similar information and formatting suitable for use on organization websites and newsletters. SAGA advertising about the AGM and Reunion events are included in the messaging.

SaskOats became a new member of CPW Saskatchewan Inc in October 2021. Several of the CPW organizations collaborated and will cost-share the teleconferencing account services provided by AV Prairieland Park AV Facilities and the technical support for dry runs and AGM Zoom sessions and voting systems.

I) President's Report – Jason Fradette

In my 2021 President AGM report I noted:

"we were not aware that a pandemic would come to impact SAGA activities this year (2020). Overall many events and typical SAGA activities were affected including this 2021 Annual General meeting which is being held virtually, and our 2021 reunion being postponed to next year. "

I could end this report right here and say this year ended up much the same way, but that would be overlooking a lot of the work of the SAGA Executive in 2021.

This year we faced the question - are SAGA members comfortable with resuming activities, especially the face-to-face reunion? As pandemic restrictions started lifting this summer the Executive considered SAGA members input, as well as input from TCU Place and the College of Agriculture and Bioresources indicating a return to more normal activities in 2022.

In September the Reunion and Banquet were booked and class chairs in place to have double the number of graduation years in attendance. Health protocols, such as proof of vaccination were to be required.

The new Covid variant emerged just as we started ticket sales, and it was no surprise that sales were reduced. By December it was evident that we could not go ahead with our annual event and the decision was taken to cancel for 2022. There is now a need to look into options including a summer event or a larger 2023 reunion.

So as President in 2021I have not been able to attend events as would normally be the case including missing the opportunity to address the Honour years at the Banquet. I was able to record a video message on behalf of SAGA which was part of the ASA virtual graduation this spring, however Bean Feed and fund raising events with the ASA could not take place in person.

However during 2021 other SAGA activity continued. Our meetings are now all virtual, which has the benefit of better accommodating executive members outside of Saskatoon. These last couple of years has emphasized that SAGA's efforts on the newsletter, the website, and social media are all important tools to allow grads to stay connected and we need to ensure these can continue.

Also we need to continue the work started in the past several years to connect SAGA with the students and the Agriculture Students Association. While it's difficult for the ASA to hold events right now we will need to look forward to bringing SAGA support for these as soon as allowable. Our scholarship is one tool that we need to grow and continue. And recently we started a discussion on SAGA sponsorship of student academic activities which may afford us another tool in maintaining connections with undergrads.

We are hearing from a lot of members that maybe some alternatives or options to the January reunion weekend need to be considered. There are suggestions that the event will need to be different in the future to appeal to more grads, and suggestions that we think about a summer option that may allow for an outdoor gathering. With our recent cancellations of the reunions, 2022 may be the year to test out some of these options

So I would like to recognize the work of our executive in 2021, they kept everything moving and probably did more planning and work on our cancelled events than would have been done normally. We're all hoping that the next year will see a return to more typical SAGA activity.

Thanks for allowing me a second year in the president chair, it's been two interesting years.

In conducting the compilation I reviewed each expenditure line as there are relatively few such entries. I did not review each revenue item as there are many more such entries. I reviewed several individual revenue items, comparing the entry on the appropriate spreadsheet to the underlying document. I found no errors.

I have made relatively few changes to the operating statement, these changes are:

During the 2018/2019 year there two deposits made which equaled a total of \$320.00 The source of the deposits were four banquet tickets for the 2020 banquet and a one year membership. The revenue from the sale of the banquet tickets relates to activity during the 2019/2020 year and therefore should be included as income during that year. I therefore increased revenue during 2019/2020 by \$300.00 Income category 4c – "Banquet and Mixer"

Previous year and the 2019/2020 as presented did not include income generated by the increased value of the BMO Growth Fund. I have included an amount equal to \$2,317.80 Category 6 "Interest" Previously the income generated by the investment has been accounted for in the Statement of Assets and Liabilities. One of the reasons for including the item in the Income Statement, in addition to bringing the statements closer to being in line with GAAP, is the current Treasurers intention to use an off the shelf accounting package beginning in 2020/2021. It is almost certain that such a program will be designed such that all financial statements are in balance.

Cheque #526 is for a deposit on the 2021 banquet. As presented this was included as an expense for 2019/2020. This is in fact an expense for the 2020/2021 year.

Cheque #528 and #532 were not included in the statement as presented. I therefore increased expense by \$1,064.24. Category 16b – "website"

During the year, there were four copies of the book "The Sodbusters Vision". These books are included in inventory at a value of \$11.74 each. I therefore added \$46.96 to expenses.

Cheque # 538 – payable to U of S for Vern Racz Scholarship was not included in statement as presented. I added to expense – category 18g – miscellaneous. You may want to re-categorize this.

The total of changes is Income increased by \$300 and Expenses increased by \$111.20

Net change therefore is \$188.80

I have updated Statement of Assets and Liabilities to reflect the above.

I have also prepared one additional statement – Sources and Uses of Funds- you may or may not find this useful.

I also note that cheque #538, to U of S for Vern Racz scholarqship, Cheque #537 to Canada Post and Cheque #536 to Crop Production show are not dated. I don't think much hinges on this but it would be better to properly date all cheques

I also notice that in the material you provided to me there is a printout from a Government of Canada web site. This printout includes the following for Corporations with Gross annual revenues of less than \$50,000 "Members must appoint a public accountant(PA) at each annual meeting. Exception – Members may wave appointment by annual unanimous resolution. (If no PA (Public accountant) is appointed, then only a compilation is necessary.) - I made a fairly superficial review of minutes and could find no such resolution.
