4) Business Arising from the Minutes:

a) Diploma Review -

K. Vancha, V.Peters, L. Horn & T. Ife gave an overview of the Diploma Review meeting on March 14, 2007 with Karen Tanino. It was a productive meeting, which gave Karen insight as to how to structure the new program. Many of our suggestions were similar to the direction of the paper that G.Hass had presented at last month's SAGA meeting.

L. Horn would like to acknowledge and thank again G. Hass for his time and direction he put into this paper as it is really setting a good foundation for the review panel to base some decisions from. L.Horn also commented that a good effort needs to be put into marketing and promotion of the college in order for industry and new prospective students to know what is available with a Degree or Diploma from the College of Agriculture and Bioresources.

G. Hass has met with the Dean's office and spoke with Karen Tanino, it looks like they will have all students taking triple number courses. They are having some transition issues that will get worked out eventually. G. Hass is pretty optimistic with the overall direction the College is taking with this review.

- S. Dreger commented that the ASA is focused on being more involved in the positive promotion of the College and plans are being made to have a stronger representation at Orientation and the U of S Experience Us events. Some suggestions are to have some former graduates from the college give talks or direction to new students as to opportunities and what direction the industry is going.
- K. Sapsford thanks everyone for their involvement with the Diploma Review, and will keep us posted as to future developments as they arise.

b) Obtaining Financial Stability Committee

- M. Maerz, submitted an update for K. Sapsford to present at tonight's meeting. Approximately 150 replies have been received by email. Some of email addresses are old and out of date. M. Maerz is meeting with Alumni to discuss options they will have in updating and accessing these in the future.
- J. Bessel is working on a letter to send out to commodity groups and companies in the industry for financial support for SAGA. A copy of this letter will be sent out to the members of SAGA for review. Again the purpose of this letter is to obtain financial support. J. Bessel is hoping to have some of this money inline for this early fall. The idea is to have the companies all share in the newsletter we are not selling advertising. Suggestion that the contributors to this support use the SAGA newsletter as an opportunity to promote what or where their check-off dollars are going ie: research and development, or they may want to use a venue to display job opportunities.
