Hi Jim,

I talked with our Cash Management Specialist and there is a couple more options we have for you.

- 1. **Direct debit**: With this option the member would give you their bank information and you would directly debit the appropriate amount from their account through our online banking system.
- 2. Acceptance of payment of account: With this option we would set you up as a biller and the member could pay you like they would a bill payment through their account. There would be an added cost to this option since some of the other banks would charge you for this service.
- 3. **Moneris**: If you are wanting to give your members the option of paying with their credit cards then you would have to go with this service. There are a couple of options here. You could be set up with a point a sale machine in order to take payment. Moneris also has a system called E-Select Plus which would allow you to take any payment online. The cost of this option seems pretty reasonable for what you are needing but for more details on the service charges I would have to refer you to a Moneris representative.
